I have been in communications with the DP Friends of Parks attorney Tempia about donations in the past two weeks. In order to make this process easier for the DP Friends, donations of this size will have instructions as the following:

Purpose: For Des Plaines Park District General Operations – To be deposited to Park District within 15 days.

As Tempia and I spoke, the purpose of the DP Friends is to raise funds and those funds to be used for Park District purposes only. This will clear up donations from large donors along with donations from Glow and Golf, like Fantasy Amusement, Rabine, Cordogan Clark, etc.

We will be depositing roughly \$90,000 to \$190,000 for General Operations that will be used for Lake Shore work, instead of the Lakeview Center so the foundation board feels better. The funds will be deposited into our Capital Fund. According to Tempia our 501C3 will not need to be audited by a CPA firm unless we exceed \$300,000 in a calendar year. This will not be the case. We can look to have Tempia attend a foundation meeting next month to answer any questions, Jeanette will deposit funds today into the DP Friends Account and we will transfer into Des Plaines Park District once they clear. The DP Friends of the Parks is a great fundraising organization that's primary mission is to help fund the Des Plaines Park District, no other organizations. Admin costs like attorney or auditing cost come out of the DP Friends bank account. Along with supplies that are needed for events.

At this time we will be holding the check for deposit. Also under any agenda there should be new business to bring up topics such as large donations and as for asking for future donations, this could be a challenge based on reactions from the Park Foundation Board members. Being associated with a group that can donate and has already donated is a huge impact to the community.

Brian, Jeanette and I understand that the separation of staff from the Friends is an important one and we would like more separation. However it was my call to get Jeanette and Brian involved in the DP Friends because of the lack of involvement at events can have an impact to the Park District. As you know putting on events that are not good looks bad for the park district and we have not had that due to the involvement by our staff. Kudos to staff involvement to raise large donations at Glow Golf because it takes a lot of work. Truthfully these dollars are assumed by corporate donors to be immediately used for Des Plainns Park District programs, not for Foundation best practices. I'm hoping that the park district has done their due diligence on both the owners of the foxtail and the foundation that this check is coming from, but we have not. If the park district has any vetting research to share, please do.

Let me preface the rest of what I'm about to write with this: as long as what we're doing is legal, and it benefits the park district, I am in favor of doing items like this. We are, in fact, an organization whose goals are to help benefit the des plaines park district. With that said, Don, if you have documents from legal counsel that state this type of transaction is legally sound, and a document from the donor stating that these funds need to be allocated to a certain project to be completed by the park district, I welcome you to share those with the Friends. I think a part of the board's apprehensions is a lack of understanding exactly what is happening here, and whether something like this is legal to carry out. This is the first deal of this type that the Friends would be completing, and definitely the largest one, and many of the board members do not have that type of experience to draw upon. Gaining a bit of knowledge in this situation does not seem like a bad thing to me, and I welcome seeking counsel of some type whether it comes from the park district's legal team or on our own.

I would also say that it is probably long overdue for the friends to have their own accountant overseeing the books, especially if we are going to be getting larger strings-attached donations in the future that will be going towards certain projects completed by the park district. Although it may have been convenient in the past to do it the way we were, the conflict of interest looks to be too high going forward now.

Although I could understand why the park board may have questions on why we are holding funds in our account, since the beginning of the Friends we have decided that the majority of the funds we disperse would be towards scholarships helping the underprivileged take part in park district activities. How's the saying go, it's easy to raise money, but hard to spend it (did i just make that up)? For many years it was difficult getting people to accept the money we were trying to give away but the last few years under the new system it seems to be working much better at giving away our

allocated amount each year (or more). And I contest the fact that we're holding funds just to hold them. When the park district comes to us with a \$5000 request for powerplay, \$4000 for preschool equipment, or \$10000 for junior warriors, sometimes at the last minute, as long as it helps kids we've been there.

Which brings us to the other point of apprehension that many board members have, and it is the definition of the Friends relationship with the Park District. As I coincidentally sit writing this in my ugly maroon original Friends of the Parks t-shirt, I remember the original intent of this foundation was to be seperate from the Park District, but to be two organizations that help each other who have aligned goals. That arrangement seemed to work for a long time, but at some point it began to shift. Maybe it was the many last minute big dollar requests that needed an answer that day, maybe it was a lack of leadership on my part, but the relationship seems to have deteriorated. If the two organizations are supposed to be operating in the separate but help each other model, I do think some more transparency on the part of the park district about what their needs are and what they'd like to do going forward would be helpful in running the Friends. If the relationship is to be one of the Friends being a subservient underling to the Park District instead of a partner, then it might be time for the Park District to run their foundation as they see it. For all of the unpaid volunteer hours and effort that has been put in by people on both sides to this point, I'd hate to see it end this way.

Once again, barring any illegalities, I do think these donations are a good thing for the Park District and do not see any problem with them. It's always been a pleasure working with the members of the Friends and the Park District to help as many kids and families in the community as we have over the years.

I'm all for being the intermediary for this, I just want to make sure it's worth our while and the Friends of the Parks benefits. An annual donation in perpetuity from the Jessica and Timothy Canning Foundation sounds like a reasonable ask.

Nicely said Brian, as I stated in the meeting I raised dollars for the Foxtail Project instead of the Park District paying for the capital improvement. It also provides a tax incentive for those that donate because the foundation is a 501c3 and the Park District is not. In addition I said I spoke with our Park District attorney about this and as long as we manage the capital improvement, there is no issue. The intent of the Park Foundation and all of you is to raise funds and then deposit the funds to the Park District for scholarships or in this case a capital improvement. As Brian stated below and I said at the meeting these dollars will be our asset and we will not have to raise taxes to pay for these costs. The Foxtail group will provide many opportunities for the Friends of the Parks and I already had them donate \$5000 to the foundation along with \$7500 to the Backpack Program and \$5000 to Kiwanis, also mentioned at the meeting. A Park Foundation main objective is to the Park District not the Foundation, other groups, or members of the foundation. The foundation is a liability of the Park District and my name is on all the legal documents. I set it up with the help of Shawn to start the major fundraiser, Glow Golf. Now that we have a potential large donor, we should see the long term benefit to the community.

There is nothing illegal with this donation and will provide documentation if needed. In the future, since my name is on the title of the foundation, I will be more active with the finances. I have also received questions from our park Board about why the foundation is holding funds. This foundations should have \$5000 at top \$10,000 in its account, otherwise dollars should be moved into Park District accounts to provide scholarship services or capital for the Park District that best benefit the Des Plaines Park District.
